Subject: Implementation of the recommendation of 7th CPC to the Pensioners/Family Pensioners of Autonomous /Statutory Bodies.

Sir,

I am directed to refer to NIOS's letters No. 62-247/2017/NIOS/Fin./7th CPC/237 dated 24.10.2017 on the subject mentioned above and to convey the approval of this Ministry to the extension of the orders issued by the Ministry of Personnel, Public Grievances and Pension, Department of Pension and Pensioners' Welfare vide their Resolution No. 38/37/2016-P&PW(A) dated 4.08.2016, O.M. No. 38/37/2016- P&PW(A) dated 12th May, 2017 and Office Memorandum No.38/37/2016- P&PW(A) dated 06th July,2017 for revision of Pension and Pensionary benefits in respect of Central Government employees in pursuance of the recommendations of the 7th Central Pay Commission to the Pensioners/ employees of NIOS on the same terms and conditions subject to the following further conditions:

- i) The same pension facility as available to the Central Government employees as per the CCS (Pension) Rule, 1972 has been adopted by NIOS for its employees; and
- ii).The pension facility as available to the Central Government employees has been provided to the employees of NIOS after implementation of successive pay commission recommendations in the past.
- iii). The entire additional financial impact arising out of the implementation of revised Pension/Family pension, pensionary benefits as per 7th CPC would be borne by NIOS from its Internal Resource Generation(IRG).
